RESULTS OF SHARE PURCHASE PLAN

Golden Gate Petroleum Ltd (ASX:GGP) announces today that its Share Purchase Plan ("SPP") has closed with strong demand from security holders. Applications totalling approximately \$9.5 million were received from approximately 1,286 eligible shareholders. As a result, Golden Gate will raise the maximum \$6.5 million under the SPP, and all applications will be scaled back with applicants receiving 68.5% of their application amount.

The shares will be issued today. Attached is the relevant 3B.

Comments

The Board is very pleased with the strong demand by shareholders and the successful completion of the SPP has strengthened the Company's balance sheet and has further allowed retail holders to increase their holdings in GGP and in most cases their proportional ownership. GGP is now in a much stronger position as it moves forward with development of Fausse Point and the drilling of wells at Silverwood, Napoleonville and Bowtie West.
